## COMMON IDENTITY RULES

---

- `careerNumber` is the permanent football identity number.
- `digitalPassportId` is the digital eligibility token.
- `nationalId` anchors the person to legal identity verification.
- Search before creating any new member record.
- Never share credentials or approve work outside your assigned scope.

## COMMON ESCALATION RULES

---

If a record conflict, payment issue, medical flag, sanction, or access problem blocks your work, document the affected careerNumber, screen, and error message. Escalate through /intradesk instead of attempting URL manipulation, duplicate creation, or informal override.

## DOCUMENTARY GOVERNANCE

---

Every manual in this suite must be registered in lib/manuals/catalog.ts, remain safe for the global PDF renderer, and preserve a clear distinction between administrative operators and football stakeholders. New manuals must be concise, role-accurate, and ASCII-safe until the PDF font stack supports full Unicode.
